In 2018 we invested \$2,979,823 in the Y's life-changing programs and services. With the success of our long-term investment strategy, we've enabled the YGV Foundation to help more people in more communities to reach their potential.

Our strong financial position also enabled the YGV Foundation to enhance its What Really Matters Capital Campaign pledge of \$3 million in 2016 with another \$7 million in 2018. The YGV Foundation's pledge will also enable capital campaign volunteers hard at work in their communities to engage other donors to become philanthropic leaders accross the region.
