Hourly pay

Mean hourly pay gap 1

Median hourly pay gap ²



In this organization women's average hourly wages are 1% less than men's. For every dollar men earn in average hourly wages, women earn 99 cents in average hourly wages. *

In this organization women's median hourly wages are 12% more than men's. For every dollar men earn in median hourly wages, women earn \$1.12 in median hourly wages. *

- 1. "Mean hourly pay gap" refers to the differences in pay between gender groups calculated by average pay. Hourly pay does not include bonuses and overtime.
- 2. "Median hourly pay gap" refers to the differences in pay between gender groups calculated by the mid range of pay for each group. Hourly pay does not include bonuses and overtime.

In this organization women's average overtime pay is 115% more than men's. For every dollar men earn in average overtime pay, women earn \$2.15 in average overtime pay. *

In this organization women's median overtime pay is 114% more than men's. For every dollar men earn in median overtime pay, women earn \$2.14 in median overtime pay. *
